To Our Franciscan Village Residents and Family Members:

As a senior living provider, being on the front lines of dealing with the pandemic crisis has been challenging at best. Our associates are so dedicated to serving you, our residents. I think you know the extraordinary measures that have been put in place over the past weeks to ensure the safety of our associates and residents alike. Even with our best efforts to prevent the virus from entering our community, we find ourselves in another situation of containment at this time.

Today we were notified by a Mother Theresa Skilled Nursing and Rehabilitation Center associate that they have tested positive for the COVID-19 virus. This particular associate only worked in Mother Theresa Skilled Nursing and Rehabilitation Center (nowhere else on the campus) and has not worked in the building for the past seven days. Because of the associate's adherence to our call-in policies and the infection control measures that had already been in place during the time that the associate was in the facility, we are confident that the appropriate infection prevention techniques were in place. This associate was out of the building from 3/16/20 to 3/23/20. Due to our guidelines, the associate wore a mask 100% of the time they were working on 3/24/20, 3/25/20 and 3/26/20. This associate reported to work on 3/27/20 and was found to have a fever and subsequently sent home. The staff member sought additional care from their physician on 3/30/20 and was tested for the virus, letting us know today that the result was positive. It has been 7 days since this associate was in the building.

It is important to note that this case appears unrelated to the prior resident case, as this associate and that resident were never on the campus at the same time. Because of the infection control measures that had **already been in place** during the time the staff member was in the facility, there was limited exposure and/or contact with other staff and residents. This associate worked only at Mother Theresa Skilled Nursing and Rehabilitation Center on the campus.

We are doing everything possible to ensure we prevent the spread of this virus within our facility. The safety of our residents and associates continues to be our most important concern. We are in very close communication with local and state health officials to ensure we are taking the appropriate steps at this time. Our staff and residents are following the recommended preventative actions.

We have no additional residents or staff members who are exhibiting any signs of infection at this time. Please know that we are doing everything within our power to mitigate the spread of the virus within the building. Per our discussions with local health departments we are following all guidance we are receiving regarding protection for our staff as well as the other residents. Their recommendations at this time are to MONITOR all residents and staff across the community. There is NO recommendation to test anyone for the COVID-19 virus unless they would become symptomatic.

We understand that this is a time of anxiety and unknowns for all involved. 100% of our efforts are geared towards the safety of your loved ones. We are asking that you do not call the facility directly, as that will pull very limited resources away from caring for the residents.
